This Amendment does nothing to fix the problems created by the AI Moratorium in H.R. 1 – it uses broad language that would prevent the enforcement of everything from state civil rights laws to laws intended to protect children from online predators, while continuing to force states to choose between protecting people and expanding broadband access

We strongly urge Congress to protect the progress states have made in safeguarding their residents against faulty AI. For this reason, we ask you to vote no on Amendment 2602.
